<p>Hong Qiao Railway Station-Tongji</p> 	<p>A: Taxi</p> <p>B: Take Metro Line 10 to Station “Tongji University”</p>
<p>Pu Dong Airport-Tongji</p> 	<p>A: Taxi</p> <p>B: Take airport shuttle bus line 4 to Wu Jiao Chang(五角场) Station (around 20RMB), and then take a taxi to Tongji University(around 30RMB)</p> <p>C: Take Metro Line 2 to East Nanjing Road(南京东路), then transfer to Metro Line 10 to Station “Tongji University”</p>

International students are required to register on the date specified by this registration guide. You are also required to leave around one-month visa application time after your entry into China for registration and visa process. If the students fail to register within two weeks from the registration date, their registration into the program will be cancelled.

Any early entry caused visa problem needs to be under student's own responsibility. The temporary visa extension can be only done after student will officially register at Tongji University, and will start from 11th September 2017 in the earliest.

Concerning Accommodation Registration

International students should go to the local police station to apply for the Registration Form of Temporary Residence **within 24 hours** after entering China, with the completed form of RECORD OF LIVING OFF CAMPUS FOR TONGJI INTERNATIONAL STUDENTS enclosed in the package of admission notice..

- International students who live at private accommodation should register with relevant documents at the local police stations.
- International students who live at Hotel and Hostel should get the Registration Form of Temporary Residence at the reception.

Concerning Physical Examination:

The international students should make an appointment **ONLINE** for the physical examination as early as possible.

The students must have their physical examination or have their previous completed physical examination (completed in home country) authenticated at the Shanghai International Travel Health Center.

For PHYSICAL Examination, please bring:

- Passport (Original and Copy);
- Admission Letter (Original and Copy);
- Passport Photo (4 photos);
- Physical Examination Fee: 500 RMB

For PHYSICAL Certificate Authentication, please bring all of the above and:

- All original physical examination certificates and results from the home country.
- Authentication Fee: 500 RMB

International Students who fail in the authentication of their physical certificates are asked to be re-examined in China.

Physical Examination is the compulsory step for students whose study period will be two semesters at Tongji University.

Concerning Entry Visa

According to the regulations issued by the Shanghai Bureau of Exit –Entry Administration, the international students should apply for a residence permit for legal residence if the study period in China more than six months.

International students who are going to study in China should prepare admission letter, yellow sheet of JW202 form, medical report(ref. above part of “physical examination” if it is required by visa application) and other documents, and apply for an entry visa of X1 or X2 at the local Chinese Embassy or Consulate.

ENTRY VISA:

- International students, whose study period in China is equal to or more than 6 months, should apply for X1 visa for entry.
In order to apply for residence permit in China after entry, international students must get back the admission letter, yellow sheet of JW202 form and other documents after applying for entry visa from the Chinese Embassy or Consulate.
- International students, whose study period in China is less than 6 months, should apply for X2 visa for entry.
- Visa-free is not permissible for international students.

Concerning Residence Permit

International students with X1 visas are required to apply for the residence permit within 30 days of their entry.

To apply for residence permits, international students must collect all the requested documents and get introduction letters from International Student Office before **Oct. 20th 2017** and within valid period of current entry visas (only on working days). Otherwise, any application for residence permit will not be accepted.

International students should apply for the residence permits in person at:

For Residence Permit application, please bring:

- Passport
- Admission Notice issued by Tongji University (Original and Copy)
- Yellow sheet of JW202 Form issued by Tongji University (Original and Copy)
- Official Physical Examination Report in China issued by Shanghai International Travel Health Center – See “**Concerning Physical Examination**”
- The Introduction Letter for visa application (issued by International Students Office of Tongji University)
- Registration Form of Temporary Residence (Original and Copy) – See “**Accommodation Registration**”
- A passport photo

Please pay attention:

- International students can not apply for any application of residence permit or visa without registration at International Student Office of Tongji University.
- The Introduction Letter issued by Tongji University does not equal to residence permit or visa. International students should take The Introduction Letter with other documents and apply for residence permit or visa at Shanghai Exit & Entry Administration Bureau.

Insurance

According to the regulations of the Ministry of Chinese Education, the international students are required to pay 300 RMB per semester for the Chinese comprehensive insurance. Please visit the website: <http://www.lxbx.net>. for detail liability and claims. Students, whose study period at Tongji University is for two semesters, need to pay 600 RMB by registration. **Only cash** is accepted.

Internship

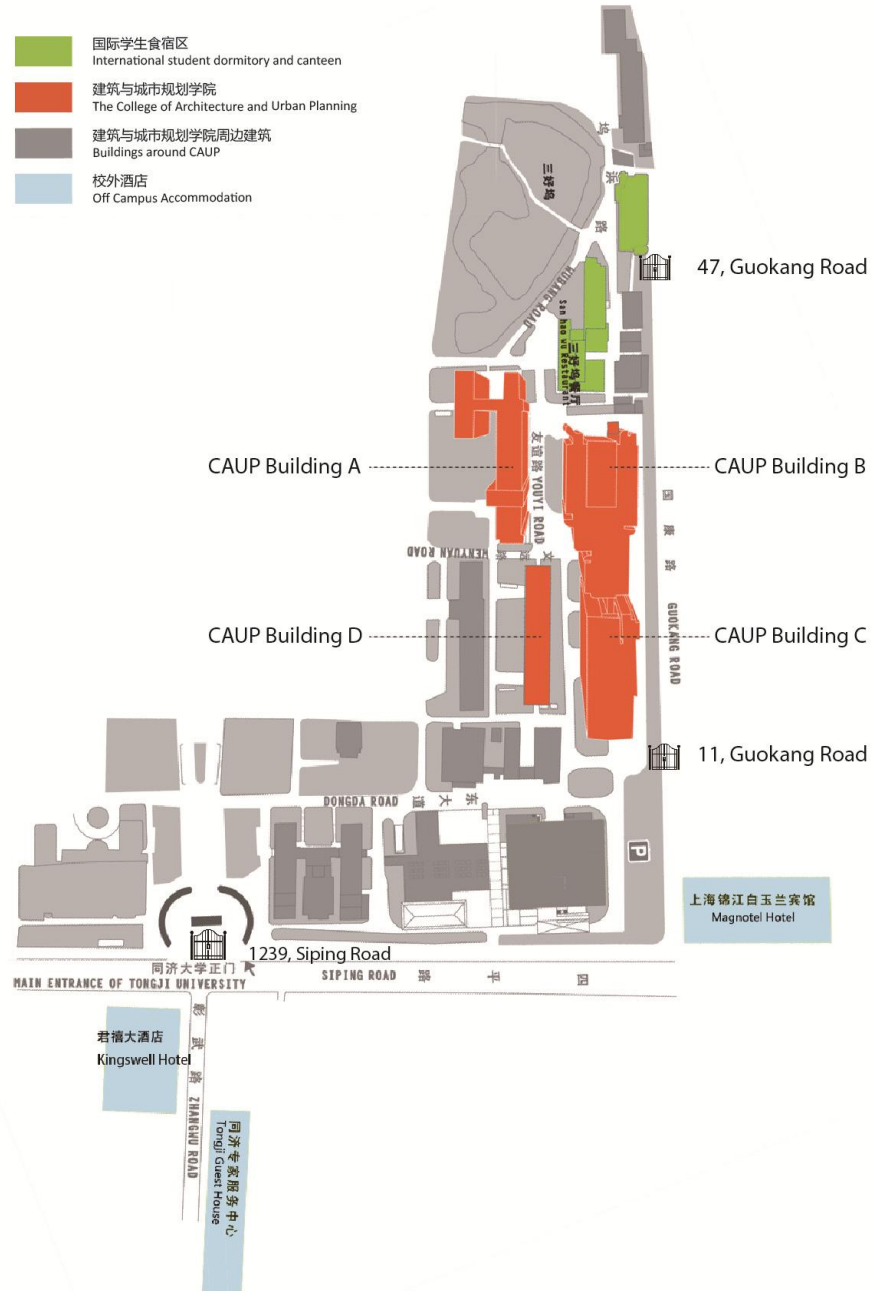
Any paid or non-paid internship is unlawful employment due to the new regulation issued by "Exit and Entry Administration Law of People's republic of China". In any case against this regulation, the employee and the university are all supposed to pay the penalty up to 5000RMB for each. And you will be then deported.

However, dual degree exchange students and non-degree exchange students with at least two semesters' exchange periods can apply for the permission of internship at CAUP International Cooperation Office (CAUP B Building, R122). The internship can only start after one semester course learning.
